Volunteers in Medicine (VIM) is committed to developing a national network of sustainable free health care clinics for the underinsured and uninsured. In order to fulfill its mission to improve access to health care for America's underserved, VIM assists community organizing groups in establishing new clinics following a proven model. The national VIM office also provides programs and educational resources to the VIM Alliance, the network of VIM clinics it assisted in developing. VIM opened one new clinic in 2017. The network of VIM Alliance clinics provided over 400,000 health care visits to more than 95,000 patients. More than 10,500 medical and non-medical volunteers shared their time and expertise in VIM clinics. Some VIM clinics even function as training centers for medical, dental, and nursing schools. The national VIM office provided one-on-one technical assistance in clinic development to 45 organizing groups in 20 states.
